GANDHI ASHRAM

Built along the river Sabarmati, this was one of the residences of Mahatma Gandhi, who lived here for 12 years. Also known as Sabarmati Ashram, this was the base from where Gandhiji led the Dandi March or Salt Satyagraha in 1930. The ashram has now been converted to a museum, displaying various aspects of Gandhiji's life.

A polygonal lake in the heart of the city, it was created more than 500 years ago. Now a popular recreational spot, the lake has boat club, natural history museum and a zoo. "Nagina Wadi" is host to a musical fountain show in the evening, in the centre of the lake.

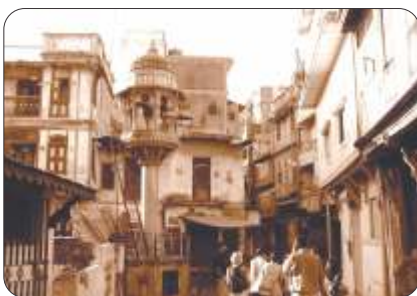
Sabarmati Riverfront is a waterfront being developed along the banks of Sabarmati river in Ahmedabad, India. The three boating stations are constructed for recreational purpose and for water-based public transport in the future.

'Thol Lake' is an artificial lake near Thol village in Kalol in Mehsana District. It was declared the Thol Bird Sanctuary in 1988 and is a habitat to 150 species of birds out of which about 60% are waterbirds. Many migratory birds nest and breed in the lake and its periphery. The two most prominent species of birds recorded in the sanctuary are flamingoes and sarus crane (*Grus antigone*).
